## How the Big Four Ranked in the 1Q21 IPO Market

The US IPO market produced its busiest quarter in over two decades, with 100 IPOs raising \$39.2 billion. Healthcare once again led deal flow with a mix of biotechs and health services providers, while the tech sector produced the most proceeds, boosted by several unicorns. The Big Four accounting firms appeared on 71 of the quarter's 100 IPOs (71%), which raised 84% of proceeds. With every offering requiring audited financials, there were 100 auditing engagements (398 including SPACs) with 22 accounting firms.

Ernst & Young was the most active IPO auditor of the 1Q21, auditing 23 deals that raised \$8.2 billion. Often the top auditor in the healthcare sector, almost half of EY's deals were biotechs, including Sana Biotechnology, which completed the largest preclinical biotech IPO ever. It worked in a variety of other sectors, and its largest IPOs included online dating app Bumble and pet supplies retailer Petco.
