How the Big Four Ranked in the 2025 IPO Market

The US IPO market continued its gradual recovery in 2025, though hopes for a full rebound were dashed by volatility from tariffs, an extended government shutdown, and a 4Q pullback in AI stocks. Still, new issuance reached a four-year high, with [202 IPOs raising a combined \\$44.0 billion](#). Sizable issuers made a more robust comeback compared to recent years, with 71 IPOs raising at least \$100 million, a more than 20% increase from last year. The Big Four accounting firms appeared on 63 of the year's 202 IPOs, most of which were larger deals, representing 85% of the year's proceeds and 31% of total deal count. With every offering requiring audited financials, there were 202 auditing engagements with 50 accounting firms, or 346 with 59 accounting firms when including SPACs.

The top auditor in the prior year, **PricewaterhouseCoopers** saw a notable decline in activity and landed in third place in 2025. The firm worked on 12 IPOs (-40% y/y) that raised \$5.3 billion (-38% y/y). Healthcare remained an important vertical, including diagnostics-focused issuers Lumexa Imaging, Heartflow, and BillionToOne. However, the firm represented a wide range of sectors, and its largest clients by deal size were led by corporate expense platform Navan, secondary ticketing marketplace StubHub, and specialty insurance platform Accelerant.

KPMG slipped to fourth place in 2025 amid a notable slowdown in IPO clients. The firm worked on 12 IPOs, down from 18 the prior year, with total proceeds falling sharply to \$4.2 billion from \$11.4 billion. KPMG's 2025 client list leaned heavily toward the technology and financial industries, including cybersecurity firm Netskope, fintech lender Figure, and insurer Aspen Insurance. Consumer-facing companies such as Chinese tea chain Chagee and specialty roaster Black Rock Coffee added sector variety, while industrial and materials issuers like Grupo Aeroméxico and Aura Minerals rounded out the slate.

Auditor Rankings for the 2025 SPAC Market

The 2025 SPAC market has seen significant activity, with a total of \$1.2 billion in SPAC IPOs completed. This represents a 15% increase from the 2024 total of \$1.05 billion. The market is dominated by a few key players, with the top five audit firms accounting for over 60% of the total volume.
