The 2Q22 IPO Market's Law Firm Leaderboard

Just 21 IPOs raised \$2.1 billion in the 2Q22, the US IPO market's slowest second quarter since 2009. Micro-caps accounted for the majority of deal flow as just six IPOs raised more than \$100 million, led by eyecare spin-off Bausch + Lomb. With every IPO requiring at least two legal firms, one for issuers and one for underwriters (and some hiring as many as five), there were 64 legal engagements with 49 law firms, or 103 with 60 firms including SPACs.

The quarter's most active law firm by deal count was **Ellenoff Grossman & Schole**, which served on four IPOs that together raised a modest \$84 million, up from one IPO in the 2Q21. The firm's roles were split evenly between company counsel and underwriter counsel. Its largest client, California-based biotech Belite Bio, raised \$36 million. Ellenoff's remaining clients were Asia-based micro-caps. EGS is best known for its SPAC business, appearing on 147 SPACs last year and just 6 traditional IPOs; in the 2Q22 it worked on two SPACs.


