### How the Big Four Ranked in the 3Q22 IPO Market

It was the worst third quarter for new issuers in over a decade, with <u>25 IPOs raising \$2.4 billion</u> as the 2022 US IPO market remains on track to raise the lowest proceeds of any year in our firm's 30+ year history. Small deals continued to account for a majority of activity, and just three IPOs raised \$100 million or more, led by billion-dollar AIG carve-out Corebridge Financial. The Big Four accounting firms audited four IPOs, including all three sizable deals, representing 86% of the quarter's proceeds but just 16% of total IPOs. With every offering requiring audited financials, there were <u>25 auditing engagements with 17 accounting firms</u>, or <u>33 engagements with 18 firms including SPACs</u>.

# **#1 Deloitte** 2 IPOs \$310M

**Deloitte & Touche** was the most active member of the Big Four in the 3Q22 IPO market, auditing two deals that raised \$310 million. The firm's clients, both of which raised more than \$100 million, were inflammatory disease biotech Third Harmonic and Chinese fintech AMTD Digital. Deloitte also worked on two of the 10 largest companies to list via SPAC in the third quarter, cybersecurity play ZeroFox and skincare holding company Waldencast. In the pipeline, Deloitte serves as auditor for recent filer American Healthcare REIT, as well as the largest IPO on file, vehicle battery maker Clarios International.




